Report from the Chair

Sarah Crest

- Sarah suggested that we need to have advertised short programs to interest attendees and foster new membership
- Volunteer(s) are needed to update the MILEX poster session for MLA Annual Meeting

 - Sarah has previously presented poster sessions as examples
 - PR is important for attracting new members MILEX needs to use branding to get the word out

MILEX Listserv

Uta Hussong

- Uta announced that got a new job and will be moving to the West coast, therefore the listserv needs to be moved from UMBC to Yahoo or Google groups ***Note: Brandy Whitlock has agreed to take care of the online discussion group that will replace the LIST previously hosted by UMBC.***
 - o After discussion, it was decided that the choice of either of these services would be fine and Uta was given the go ahead to make the choice
 - o It was noted that a list can be closed to anyone but subscribers, which should eliminate any data mining from names on the list
 - o Google can link up to a calendar, but it is cumbersome
 - o Treasurer duties Treasurer needs to be someone from USM campuses because the USM Foundation handles MILEX monies ***Note: Sean Henry has volunteered to serve as treasurer for MILEX.***
 - USM Foundation changed to a new accounting system this past summer, which may have caused some problems with \$130 of MILEX deposits.
 - USM account requires a co-signer for every request for money that goes out
 - We had discussed alternatives to USM Foundation in the past and may want to consider this again (Note: Agenda item for next meeting?)
 - Treasurer's report
 - \$10.30 in bank fees (ie. \$.60 \$.75 per transaction)
 - Total amount in our account = ~ \$1700

Conference Updates

Susan Cooperstein

- Expensive proposition which will require support other than our treasury monies and in addition to registration fees
 - Sarah Crest will work on this
 - Susan has gotten some proposals, but not necessarily on critical thinking
 - Once we have Ken Bain under contract, we need to include this in our PR
 ***Sara will pull together information on Bain with help from Randy Smith ***
 - Will send out conference info on LISTSERV so that member can use it to recruit attendees
 - Stephen reported that the MILEX Web site is set up for PR purposes- main page, due dates for presentations, due dates for registration, evaluation – need to create the evaluation form

Program - Using LibGuides.com to Create Pathfinders and Resource Guides Ginny Polley

- LibGuides prevents the problem of moving Web sites
- LibGuides has received a lot of publicity
- 135 libraries in SpringShare
- Paying less than \$1000/yr, Brandy at AACC is paying \$300/yr.
- Fees are based on FTE and there may be a discount for community colleges
- Acadia university provides a good example of a university that uses LibGuides
- Some interface features:
 - o What are you studying dropdown to LibGuide
 - o You can standardize tabs
 - Good with updates
 - Doesn't update automatically each nugget can be reproduced on any page
 - Most students get into these Web guides from Blackboard or their instructor's page
 - o Can put tabs on each page
 - o Compatible w/ facebook also Web 2.0 compatible
 - Some trouble with uploading images
 - New feature allows multiple editors on one page
 - Rich text is the most flexible choice, embedded video, interactive poll- no easy way to reset it
 - Very flexible and ease to use
 - o Can publish page privately for comments
 - o Can link to Library website or easy proxy prefix
 - Easy to put up a quick evaluation form done w/ Adobe and Cold Fusion
 - Example: apps.vjc.edu/library/forms/instruction-eval.cfm
 - Comments go to Ginny's E-mail account
 - Evaluation forms needs to cut out data entry portion –this can be done with MS Access
 - o Searchability What kind of search results do you get?
 - Searches tags getting ready to roll out a full text search

- Popular tags do variable size tag cloud can add these to pages
 can also be put on home page
- Added subject headings to guides- only one allowed so far
- Pros
 - o The company is very responsive only once a server outage
 - o easy to use
 - o can help with collaboration between faculty and librarian
 - o can change colors and graphics of your own library page
 - o rich content can be entered easy to use in BB
 - Not a big ticket item
 - o takes everything off server that would normally sit on own server -
 - o Been around since June 2007
 - o major search engines can find them
 - o can ask for a particular domain so that it
- Cons
 - Stability of third party product –
 - Annual fee
- Sean is putting in code to paste in search boxes for databases you can do this in LibGuides
- It's a good idea to train and to have someone on the library staff who knows the system well enough to answer questions and troubleshoot
